

# **Birthday Dreams**

## **Job Description and Expectations**

**Purpose:** To advise, govern, oversee policy and direction, and assist with the leadership and general promotion of Birthday Dreams so as to support the organization's mission and needs.

Mission: To provide birthday parties to homeless children in the Puget Sound area.

## \*Major responsibilities:

- Organizational leadership and advisement
- Formulation and oversight of policies and procedures
- Financial management, including adoption and oversight of the annual budget
- Oversight of program planning and evaluation
- Personnel evaluation and staff development
- Review of organizational and programmatic reports
- Promotion of the organization
- Fundraising and outreach

**Length of term:** Two years, which may be renewed indefinitely, pending approval of the board. Term limits may be enacted by the board at a later date.

#### Meetings and time commitment:

- The board of directors meets on the third Wednesday of the month, 7:00 8:30 p.m., currently these meetings are held virtually via Teams.
- Committees meet an average of four to 12 times per year, pending their respective work agenda.
- The Annual Meeting is in the first quarter and is a mandatory meeting for all board members.

<sup>\*</sup>Members of the board share these responsibilities while acting in the interest of Birthday Dreams. Each member is expected to make recommendations based on his or her experience and vantage point in the community.



## **Expectations of board members:**

- Know the organization's Mission and Vision.
- Attend and participate in board meetings on a regular basis, and special events as able.
- Participate on at least one standing committee and serve on ad-hoc committees as necessary.
- Come to all meetings prepared, having reviewed any and all materials distributed prior to the meeting.
- Actively participate in expanding the reputation and operation of Birthday Dreams in our coverage area by:
  - Help communicate and promote Birthday Dreams' mission and programs to the community.
  - Seek in-kind services for Birthday Dreams to the extent possible.
  - o Fundraising and outreach
  - Use Birthday Dreams information and fundraising tools, such as website, brochures, and social media.
  - Be alert to community concerns that can be addressed by Birthday Dreams' mission, objectives, and programs.
- Become familiar with Birthday Dreams' finances, budget, and financial/resource needs.
- Understand the policies and procedures of Birthday Dreams.
- Maintain highest ethical standards and report any potential violations of the conflict-of-interest or confidentiality policies.
- New board members: There is a \$500 monetary donation or sponsorship expected in the first 90 days (about 3 months) of being elected to serve on the board. The R&D committee will ensure that this request is clearly called out as a part of the interview/ selection process to avoid surprises. (If your company matches you can donate \$250)
- As a current board member, there are 2 financial contributions expected annually. One financial contribution for the Gala and one financial contribution for Miles. (see Board Strategic Plan for detailed information on the ways to achieve this financial commitment)
